 A guard post may be required if the new location is near a parking or loading zone. NW Natural will provan actual cost estimate up to 6 months in advance of the project's completion. After that time, the cost estimate must be recalculated at current construction rates. NW Natural or its agent will perform the relocation, which will be subject to NW Natural's scheduling price.
